The Research Centre for Sustainable Hong Kong (CSHK), established in June 2017, is an Applied Strategic Development Centre of CityU. CSHK houses the SusHK Hub and supports all the research and collaborative activities with stakeholders from different sectors and regions. The mission of CSHK is to analyze and develop solutions to meet critical sustainability issues in Hong Kong from a multi-disciplinary perspective. Priority research themes include economic and social sustainability, and the development of Hong Kong professional services along the Belt-Road (B&R).

CSHK members come from a variety of disciplines at the City University of Hong Kong, including Political Science, Philosophy, International Relations, Behavioural Science, Sociology, Law, Media and Communication, Economics and Finance, Accounting, Management Science, Civil Engineering and Electronic Engineering. Professor Linda Chelan Li, Department of Public and International Affairs, is Centre Director. Professor Phyllis Mo, Department of Accountancy, is Associate Director.



SUSHK HUB

The Sustainable Hong Kong Research Hub (SusHK Hub) was established by a multi-disciplinary research team based in City University of Hong Kong (CityU) in November 2016. It is an open platform for impactful applied research on real-life sustainability issues in Hong Kong and the region.

SusHK Hub aims at facilitating synergies and collaborations among the academia, industry, professional services and business sectors, government and community in Hong Kong, Mainland and overseas.








