### **Abstract**

Students will be required to undertake individually supervised research and produce a dissertation.

The purpose of the oral presentation is to test the student's comprehension of the content and context of the dissertation, and to confirm that the work presented is that of the student. The oral presentation will be made before a panel appointed by the Dissertation Coordinator and normally comprise the Dissertation Coordinator or the Chairman of the Examination Board as Chairman, the dissertation supervisor and the second assessor.
